Salai Village, Via Vikaravandi, Villupuram District to conduct GNM, B.Sc.,(Nursing) and Post Basic B.Sc., (Nursing) Courses from the academic year 2014-2015, subject to the following usual conditions:
 - a) Admission of students shall be made as per the rules fixed by the Government from time to time

- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.
- c) The Trust should obtain recognition / suitability / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, Indian Nursing Council, New Delhi and Tamil Nadu Dr. M.G.R. Medical University respectively for the new address.
- d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons,
- e) The Trust should not run any other Nursing institution within 10 kms radius.
- 4. The Director of Medical Education is directed to take necessary action accordingly.

EXAMINATION

No candidate shall be permitted to appear in any one of the parts of B.Sc. in Nursing Degree course (Basic) Examinations unless he/she has attended the course in the subject for the prescribed period in an affiliated institution recognized by this University and produce the necessary certificate of study attendance, satisfactory conduct and progress from the Head of the institution.

A candidate is required to put in a minimum of 90% of attendance in theory and 100% in practical separately in each subject before admission to the examinations

The classes for Under Graduate students will commence from 1st September of every year and the University examination will commence from 1stAugust of the subsequent year. Therefore, the attendance will be calculated for the Under Graduate students from 1st September of the same year to 31st August of the next year including examination period.

If the candidate is lacking attendance in any one of the subject(s), he/she will be detained for the subject(s) in whom the candidate lacks attendance but will be permitted to appear for the rest of the subjects in which the candidate is having minimum required percentage of attendance.

A candidate must have 100% attendance in each of the practical areas before award of Degree.

CONDONATION OF LACK OF ATTENDANCE:

There shall be No condonation of lack of attendance.
 (There shall be no condonation of any leave for any

- reason including Pregnancy, Child Birth, and Medical conditions of any nature).
- The maximum period to complete the course successfully should not exceed the double duration of the course.

SUBMISSION OF DISSERTATION

- The candidate shall submit a dissertation in the field of specialty, two months before the final examination for valuing the certification. During the program of study the candidate is required to do dissertation in his/her specialty.
- If the candidate fails to submit within the stipulated time given by University, He/ She can submit within another 10 days with penalty of 2500 and can submit 10 day before the commencement of with addition penalty of Rs.4000 to the university.

GENERAL RULES OF CONDUCT

Timings: College timing- 9.30am to 4.30pm. & clinical timing is 7.00am to 4.00pm.

Dress code: All students shall wear neat, clean and decent dress. Girls shall wear salwar kameez /Chudidhar/Sarees. Boys shall wear Pant and shirts.

- 1. Students shall wear shoes while attending the clinical posting.
- 2. During the clinical posting students should come in neat & clean uniform with apron.
- 3. Students found violating the dress code will not be permitted to attend the class. If it is repeated the

matter shall be brought to the notice of the Disciplinary committee.

Identity card:

- 1. Every student admitted to the college will have to wear the Identity Card during working hours.
- 2. Students who has lost their ID card has to obtain a duplicate card by payment of Rs. 100/- after the written request made to the Principal

Punctuality

- 1. Students are expected to attend the classes and clinical practices regularly and punctually.
- 2. Students are expected to follow classroom etiquettes.

Conduct and Discipline

- 1. A disciplinary committee is constituted with a view to manage students discipline efficiently and effectively. The Disciplinary committee has the power to directly call for an enquiry into any event affecting students discipline on and off campus. They can summon on any students to appear before them in relation to an enquiry into any issues related to student discipline.
- 2. The disciplinary committee also has the power to request any member of the administration or faculty to assist in the enquiry.
- As a responsible member of the institute, every student should maintain high standard of discipline, courtesy and behavior both inside and outside the campus.
- 4. Students are expected to behave politely and in courteous manner towards the staff.
- 5. Students are strictly forbidden from consuming drugs and intoxicants. Anyone found under the influence of alcohol/intoxicants/drugs will be expelled from the Institute.

- During the class hours, students are forbidden from loitering along the corridors or roads. Students are required to spend their free hours in the library. Any violation will be viewed seriously.
- 7. Mobile phones are strictly banned in the class rooms/ Campus. If found it will be seized.
- 8. Students who violate any of the rules and regulations Disciplinary Committee will take the following actions:

Books issue and return time: 08.00 am to 09.30 am - 12.30 pm to 01.00 pm - 04.45 pm to 06.00 pm.

- Maintain silence and avoid unnecessary discussion in library.
- ❖ Both the staff and students should sign the register before entering the library.
- ❖ Note, Own Books are not allowed inside the library. Only papers are allowed to take Notes, get permission from librarian while leaving the library.
- ❖ Books to be returned within the regular of 1 week period.
- Books will be renewed only once. Next time it should be replaced.
- Replace books on specified due date, if fails, penalty will be imposed.
- ❖ Reference Books, Question Bank, Syllabus will not to be issued for taking Xerox.
- Without class co-coordinator permission the students are not allowed during class hours.
- Loss of borrower book should be reported to the librarian. It should replace with the new one of the same within 15 days.

ANTI RAGGING RULES AND REGULATIONS

(UGC regulations for curbing the menace of ragging in higher educational institutions 2009) (Under section 26(1) of the university grants commission act, 1956)

- 1) Abetment to ragging
- 2) Criminal conspiracy to rag
- 3) Unlawful assembly and ragging
- 4) Public nuisance created during ragging
- 5) Violation of decency and morals through ragging

- 6) Injury to body, causing hurt or grievous hurt
- 7) Wrongful restraint
- 8) Wrongful confinement
- 9) Use of criminal force
- 10) Assault as well as sexual offences or unnatural offences
- 11) Extortion
- 12) Criminal trespass
- 13) Offences against property
- 14) Criminal intimidation
- 15) Attempts to commit any or all of the above mentioned offences against the victims.

RAGGING PUNISHMENT

Depending on the nature and gravity of the guilt established by the anti- ragging squad, awards, to those found guilty, one or more of the following punishments namely,

- Suspension from attending classes and academic privileges.
- Withholding / withdrawing scholarship/ fellowship and other benefits.
- Debarring from appearing in any test / examination or other evaluation process.
- Withholding results
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc...
- Suspension from the institution for ragging for a period of one to two years.

 Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

WOMEN HARASSMENT REDRESSAL CELL:

(UGC regulations for prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions 2015) (Under Act No 14 (2013))

Women harassment cell is established in Our College for preventing the sexual harassment as well as providing a healthy and congenial atmosphere to women employees and students in our institutions.

Sexual harassment includes such unwelcome sexually determined behavior (whether directly or by implication) as:

Physical contact and advances;

- b) A demand or request for sexual favors;
- c) Sexually colored remarks;
- d) Showing pornography;
- e) Any other unwelcome physical verbal or non-verbal conduct of sexual nature.
- Sexual harassment need not involve physical contact. Any act that creates a hostile work environment - be it by virtue of cracking lewd jokes, verbal abuse, circulating lewd rumors etc. counts as sexual harassment
- The creation of a hostile work environment through unwelcome physical verbal or non-verbal conduct of sexual nature may consist not of a single act but of a pattern of behavior comprising many such acts.
- Thus, it is important that the victim report such behavior as soon as possible and not wait for it to become worse. In some cases, the psychological stigma of reporting the conduct of a co-worker might require a great deal of courage on the part of the victim and they may report such acts after a long period of time. The guidelines suggest that the complaint mechanism should ensure time bound treatment of complaints, but they do not suggest that a report can only be made within a short period of time.
